Subject : Grant of Dearness Relief to the Bihar Govt. pensioners/ family pensioners on their un-revised pension/family pension with effect from 01-01-2011 and 01-07-2011.

In continuation to this office circular No. Pen. Co-ordn./Bihar/Vol.- VIII/DR-un-rev&Arrear/111 dated 29-08-2011, this is to state that the Govt. of Bihar in their FD Resolution Nos. 3A-3-Allowance-01/2009 - 5211 dated 10-06-2011 and 3A-3-Allowance-01/2009 - 10803 dated 29-11-2011 have sanctioned dearness relief to their pensioners/family pensioners whose pension/family pension have not been revised in the light of Govt. of Bihar FD Resolution No. B.-27/Pay Co.-137/2008-820 dated 23-09-2009 (circulated vide No. Pen. Co-ordn./Bihar/Vol.-VIII/Revision/185 dated 18-03-2010) at the rate and from the date as under :-

Date of effect	Rate of Dearness Relief per month	including Dearness Pension/Dearness Family Pension
01-01-2011	115% of basic pension/family pension	
01-07-2011	127% of basic pension/family pension	

2. Payment of dearness relief involving fraction of 50 paise and above may be rounded off to the next higher rupee and fraction less than 50 paise may be ignored.

3. Persons appointed by minister or persons getting minister-level facilities will also be paid dearness allowance in cash at the above mentioned rate.

4. So far as application of this order in respect of the retired employees of the Patna High Court/Bihar Legislative Assembly/Bihar Legislative Council is concerned, necessary orders will be issued separately by the respective secretariat/office after obtaining the concurrence of the Chief Justice, Patna High Court/Speaker, Bihar Legislative Assembly/Chairman, Bihar Legislative Council, Bihar, Patna.

5. Incidentally, it may be mentioned that this circular is issued to other Accountants General just to remind them the applicability of this order to the West Bengal Govt. pensioners/family pensioners guided by Bihar Pension Rules.

6. Having been authorised by the Accountant General (A&E)-II, Bihar in their letter No. Pen-IX-Spl. Seal Authority No. 1135 dated 27-12-2011, it is requested to make necessary arrangement for payment of dearness relief @ 115% and 127% with effect from 01-01-2011 and 01-07-2011 respectively to all eligible Bihar Govt. pensioners/family pensioners as well as West Bengal Govt. pensioners/family pensioners guided by Bihar Pension Rules on their pension/family pension and dearness pension/dearness family pension after proper adjustment.

7. The charges on this account for the pensioners/family pensioners of Govt. of Bihar are debitable to the Govt. of Bihar under the head "8793-I.S.S.A/cs.; Govt. of Bihar etc" and the charges for the West Bengal Govt. pensioners/family pensioners guided by Bihar Pension Rules are debitable to the Govt. of West Bengal under the head "2071-Pension and Other Retirement Benefits".
