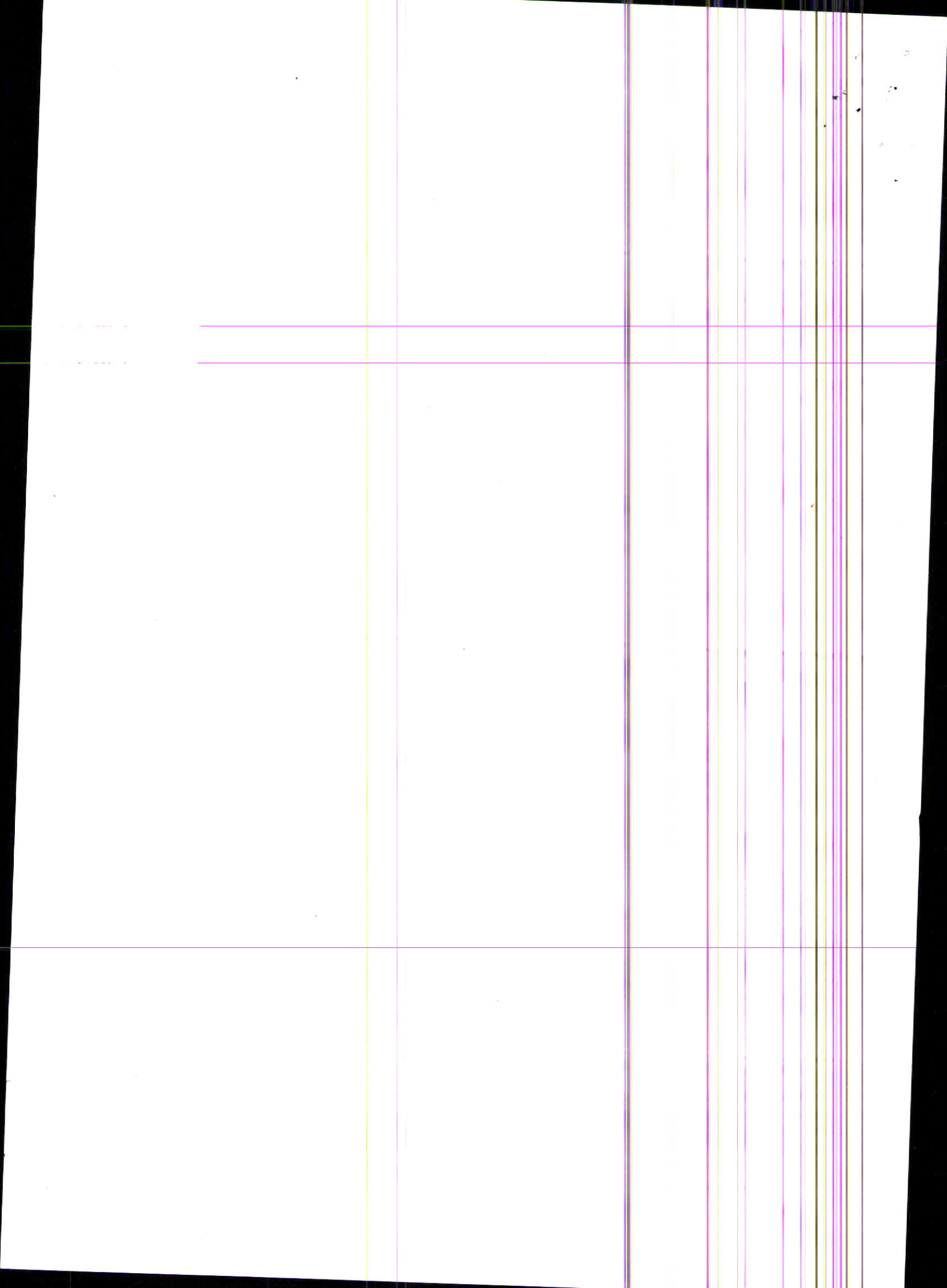



As per OM cited 1st, the Dearness Allowance payable to Central Government pensioners/family pensioners Drawing pay in the pre-revised scale came into force with effect from 1.1.2006 has been enhanced from the existing rate of 136% to 139% with effect from 1.7.2017.

Government of Kerala as per orders cited 2nd have extended the benefit of increase in Dearness Relief sanctioned to Central Government pensioners/family pensioners to the retired State Judicial Officers/nominees without waiting for further orders from the State Government.

Hence, you are requested to honour the claim for enhanced Dearness Relief at the rate of 139% with effect from 1.7.2017, preferred by pensioners/family pensioners coming under the category of State Judicial Officers in respect of whom pension/family pension has been revised based on replacement scale came into force with effect from 1.1.2006.
