

Subject: - Revision of Rate of Dearness Relief to State Govt. Pensioners/family pensioners w.e.f. 01-01-2024.

In pursuance to the Govt. of India, Ministry of personnel, Public Grievances & Pension OM.No.42//02/2024-P&PW(D) dated 13th March'2024(copy enclosed) on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Relief (DR) payable to State Government Pensioners/Family Pensioners shall be enhanced by 4% from the existing rate 46% to 50% of the basic Pension with effect from 1st January'2024. The DR arrears for the period from 1st January'2024 to 31st March'2024 shall be paid in cash.
