3. The amount of revised Temporary Increase with effect from dated: 01-10-2016 to 01/01/2017 will be paid in cash to the State Govt. Pensioners/Family Pensioners. It will be decided separately for the arreas of the revised temporary Increase of the dates between Dt.01/07/2016 to Dt.30/09/2016.

4. It will be the responsibility of the Pension Disbursing Authority, to calculate the quantum of Dearness Relief payable in each individual case.

<u>5.</u> All Accountant General of the respective States/Central Administrative Authority except Gujarat State are requested to take necessary action to authorize
