

Sub:-Grant of revised rates of dearness relief with effect from 1/1/2016,1/1/2017 & 1/1/2018 to the pensioners/family pensioners of Ex-Management Staff of North Bengal Medical College& Burdwan Medical College

In continuation to this office circular no Pen.Co-ordn/258/Vol-II/217/Vol-II/246 dated 11/3/2015, it is stated that the Govt. of West Bengal, Higher Education Department, University Branch in their Memo no.s 16-Edn(U)/N/1U-01/14 dated 7/1/2016, 75-Edn(U)/N/1U-01/14 dated 25/1/2017 and 1333-Edn(U)/N/1U-01/14 dated 6/12/2017 have sanctioned revised rates of dearness relief pensioners/family pensioners of State Aided Universities.

Besides, the Govt. has sanctioned revised rates of Dearness Relief @156%, @173% and @199% of Basic Pension and Dearness pension taken together with effect from 1/1/2016,1/1/2017 and 1/1/2018 respectively for the pensioners/family pensioners of the State Aided Universities, whose pension/family pension has not yet been revised.

The aforesaid benefit will also be admissible to the pensioners/family pensioners who retired/died in harness as Ex-Management Staff of North Bengal Medical College as well as Burdwan Medical College and whose pension/family pension has been regulated under University Pension Rules as per Govt. of West Bengal, Health & Family Welfare Department, TOI Branch letter no. HF/O/TOI/114/2T-03/2010 dated 13/1/2012 and Memo No.31/HF/O/TOI/3P-28/2008(PT) dated 19/11/2012 respectively.

Accordingly, all Pension Disbursing Officers are requested to make necessary arrangements for payment of dearness relief @75%,85% and 100% on revised pension/family pension with effect from 1/1/2016,1/1/2017 and 1/1/2018 respectively to all pensioners/family pensioners who retired/died in harness as Ex-Management Staff of North Bengal Medical College as well as Burdwan Medical College and whose pension/family pension has been regulated under University Pension Rules after proper adjustment. Besides, the pensioners/family pensioners who retired/died in harness as Ex-Management Staff of North Bengal Medical College as well as Burdwan Medical College and whose pension/family pension has not yet been revised in terms of Memo No.464-Edn(U) dated 13/8/2010 are also entitled to get revised rates of Dearness Relief @156%,@173% and @199% on Basic Pension and Dearness pension taken together with effect from 1/1/2016,1/1/2017 and 1/1/2018 respectively.
