**RESOLUTION:**

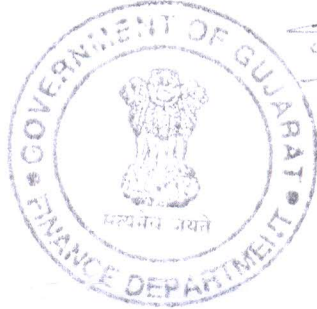
The State Government has decided to pay 9% temporary increase (Dearness Relief) to State Government Pensioners / Family Pensioners vide GR mentioned at (V) above. Government has now decided to increase the rates of Temporary Increase (Dearness Relief) admissible to State Government Pensioners/ Family Pensioners with effect from dt.01/01/2019 as under.

| No. | Admissible from date | Admissible Rate      |
|-----|----------------------|----------------------|
| 1.  | From 01/01/2019      | 12% of the basic pay |

1. Payment of Temporary Increase (Dearness Relief) involving a fraction of a rupee shall be rounded off to the nearest rupee (lower or higher).
2. Temporary Increase (Dearness Relief) at the rates indicated in above table will also be admissible on the additional basic pension/additional family pension available to Pensioners/Family Pensioners based on their age as indicated in Government Resolution, Finance Department, No. PGR-102016-6-Pay Cell, dated 15th October, 2016 and Government Resolution, Finance Department No. PGR-102016-7-Pay Cell, dated 15<sup>th</sup> October 2016.
3. The amount of revised Temporary Increase with effect from dated: 01-01-2019 will be paid in cash to the State Govt. Pensioners/Family Pensioners.
4. It will be the responsibility of the Pension Disbursing Authority, to calculate the quantum of Dearness Relief payable in each individual case.
5. All Accountant General of the respective States/Central Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat Pensioners drawing pensioners from their State Treasuries, Including Public Sector Banks.

6. Other Provisions governing grant of temporary Increase (Dearness Relief) to Pensioners such as regulations of dearness relief during employment / re-employment, regulations to temporary increase (Dearness Relief), where more than one pension is drawn etc. will remain unchanged.
