- (4) ¹If the land is not purchased and the sale deed thereof not produced for inspection of the Government within two months of the date of drawal of the part of the advance for that purpose, or within such further time as the Government/ Head of Department may allow in this behalf/ ¹if the house is not purchased and mortgaged within three months of the drawal of the advance or within further time as the Government/ Head of Department may allow in this behalf/ ¹if the borrower fails to complete the construction/ enlargement of the said house, as herein before agreed, or if the Borrower becomes insolvent or quits the service of the Government or dies, the entire amount of advance together with interest accruing thereon shall immediately become due and payable to the Government.
- (5) The Government shall be entitled to recover the balance of the said advance with interest remaining unpaid at the time of his retirement or death preceding retirement from the whole or any specified part of the gratuity that may be sanctioned to him.
- (6) Without prejudice to any other right of the Government in that behalf, if any amount becomes refundable or payable by the borrower to the Government, the Government will be entitlement to recover the same as arrears of land revenue.
