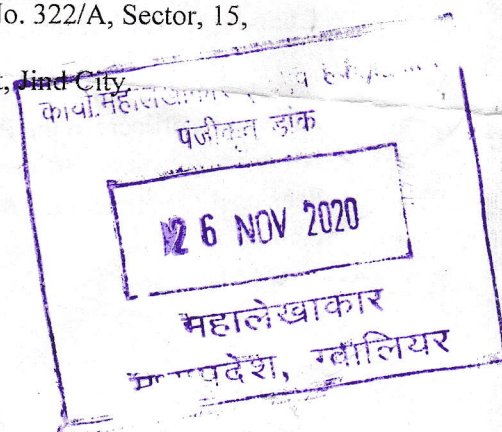

In continuation of Government of Haryana Finance Department order No. 4/7/2009-2 FR/14803 dated 31.05.2016 vide which Dearness Allowances to Haryana Government Employees on un-revised scales of pay i.e. 245 % was circulated vide this office letter no. Pen-1/Grant of DR/Gen-26/2016-17/702-786 dated 27.06.2016. Now instructions in r/o **Grant of Dearness Relief to State Government Pensioners/family pensioners of the Haryana Government at the revised rates has been received from the Haryana Finance Department in following manner.
