निराणम करहीगड No. 2/41/2010-1Pension.— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules to further amend the Haryana Civil Service (Judicial Branch) and the Haryana Superior Judicial Service (Revised Pension) Part-I Rules, 2011, namely:-

- These Rules may be called the Haryana Civil Service (Judicial 1. (1) Branch) and the Haryana Superior Judicial Service (Revised Pension) Part-I (Amendment) Rules, 2014.
 - They shall be deemed to have come into force on the 1st day of (2) January, 2006.
- In the Haryana Civil Service (Judicial Branch) and the Haryana Superior 2. Judicial Service (Revised Pension) Part-I Rules, 2011, for existing Annexure-I, under heading "Assured Career Progression scale for Members of Haryana Civil Services (Judicial)", the following Annexure shall be substituted, namely:-

pension in *Column-5* above shall be reduced pro-rata, where the pensioner had less than the maximum required qualifying service (that is 33 years) for full pension as per rule 6.16(2) of Punjab Civil Service Rule Volume-II, as applicable on 1st January, 2006 and in no case it shall be less than ₹3500/- per month. In case, the pension consolidated as per rule 5 of notification is higher than the pension calculated in the manner above, the same(higher pension) shall be treated as basic pension.

2**. The revised family pension in respect of those pensioners who retired before 1st January, 2006 and the Government servants who died before 1st January, 2006 cannot be less than pension indicated in column 6 above (that is 30% of the sum of minimum of master pay scale/scale corresponding to the scale of pay the pensioners held at the time of their retirement). In case, the family pension consolidated as per rule 5 of notification is higher than the family pension indicated in column 6 above, the same (higher family pension) shall be treated as basic family pension.

The revised Pension/Family Pension shall be fixed notionally w.e.f. 01-01-2006 and actually w.e.f the date of issue of this notification, however no recovery of excess pension/family pension shall be made w.e.f. 01-01-2006 to date of notification".

- 1. (1) ये नियम हरियाणा सिविल सेवाएं (न्यायिक शाखा) तथा हरियाणा वरिष्ठ न्यायिक सेवा भाग-1 (संशोधन) नियम, 2014, कहे जा सकते हैं।
 - (2) ये नियम जनवरी, 2008 के प्रथम दिन से लागू हुये समझे जायेंगें।
- 2- हरियाणा सिविल सेवाएं (न्यायिक शाखा) तथा हरियाणा वरिष्ठ न्यायिक सेवा (पुनरीक्षित पेंशन)भाग 1 नियम, 2011 में "अनुबद्ध र में" विघमान (भाग—II) हरियाणा सिविल सेवा (न्यायिक) के सदस्यों के लिए सुनिशिचत जीविका प्रगति वेतनमान" के स्थान पर, निम्नलिखित अनुबन्ध प्रतिस्थापित किया जाएगा , अर्थात:—

पेंशनरो द्धारा ग्रहण मास्टर वेतनमान/वेतन अनुरूप वेतनमान की कम से कम 50 प्रतिशत धनराशि) जहां पेंशनर प्रथम जनवरी 2006 को पूरी पेंशन के लिये यथा लागू पंजाब सिविल सेवा नियम जिल्द—II के नियम 6.16.(2) के अनुसार अधिकतम अपेक्षित अहक सेवा (अर्थात 33 वर्ष) से कम लेता था वहां पेंशन उकत खाना 5 के अनुपात में घटाई जाएगी तथा किसी भी दशा में यह 3500/— रूपये प्रतिमाह से कम नहीं होगी । यादि अधिसूचना के नियम 5 के अनुसार समेकित पेशन उक्त रीति में संगणित पेंशन से अधिक है तो वह अधिकतम पेंशन मूल पेंशन के रूप में समझी जाएगी ।

पेंशन / पारिवारिक पेंशन प्रथम जनवरी 2006 से अप्रयोगमूलक की जाएगी तथा वास्तविक रूप में इस अधिसूबना के प्रकाशन की तिथि से नियत होगा तथापि अधिकतम पेंशन / पारिवारिक पेंशन की वसूली 01.01.2006 से लेकर अधिसूबना के प्रकाशन की तिथि तक नहीं की जाएगी ।
