No. 2/51/2008-1Pension:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules to further amend the Haryana Civil Services (Revised Pension) Part-I Rules, 2009:-

1. These rules may be called the **Haryana Civil Services (Revised Pension) Part-I (Amendment) Rules, 2015.**
2. In the **Haryana Civil Services (Revised Pension) Part-I Rules, 2009**, (hereinafter called the said rules) after rule 6, the following rule shall be added and shall be deemed to have been added w.e.f. **06th February, 2015**:-

"6(A) (1) The pension of pre-2006 pensioners as revised w.e.f 1st January, 2006 in terms of rule 5 or 6 shall be stepped up w.e.f. 06th February, 2015 to **50% (fifty percent)** of the sum of minimum of pay in the pay band and the grade pay corresponding to the pre-revised pay scale (including Higher Administrative Grade(HAG) Scale as substituted vide **O.M.No.2/45/2009-1Pension, dated 30.03.2010** from which the pensioner had retired, as arrived at with reference to the fitment tables annexed to the Finance Department's (Pay Revision Branch) letter No. 1/83/2008-1PR(FD) dated 07.01.2009 published in Haryana Government Gazette, Department of Finance, corrigendum, dated the 27th January, 2009. Revised pension of pre-2006 pensioners shall be calculated as per **column number 8** in Annexure-IA

- (2) The normal family pension of pre-2006 family pensioners as revised w.e.f 1st January, 2006 in terms of rule 5 or 6 shall also be stepped up w.e.f. 06th February, 2015 to **30% (thirty percent)** of the sum of minimum of pay in the pay band and the grade pay corresponding to the pre-revised pay scale (including Higher Administrative Grade (HAG) Scale as substituted vide O.M.No.2/45/2009-1Pension, dated 30.03.2010 in which the Government servant had retired, as arrived at with reference to the fitment tables annexed to the Finance Department's (Pay Revision Branch) letter No. 1/83/2008-1PR(FD) dated 07.01.2009 published in Haryana Government Gazette, Department of Finance, corrigendum, dated 27th January, 2009. Revised family pension of pre-2006 pensioners shall be calculated as per column number 9 in Annexure-IA."

संख्या 2/51/2008-1पेंशन:- भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा सिविल सेवाएं (पुनरीक्षित पेंशन) भाग- I नियम, 2009 को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :-

1. ये नियम हरियाणा सिविल सेवाएं (पुनरीक्षित पेंशन) भाग-I (संशोधन) नियम, 2015, कहे जा सकते हैं।
2. हरियाणा सिविल सेवाएं (पुनरीक्षित पेंशन) भाग- I नियम, 2009 (जिन्हें, इसमें, इसके बाद, उक्त नियम कहा गया है) में, नियम 6 के बाद, निम्नलिखित नियम जोड़ा जाएगा तथा 6 फरवरी, 2015 से जोड़ा गया समझा जाएगा, अर्थात्:-

“6(क)(1)-नियम 5 अथवा 6 के निबन्धनों में प्रथम जनवरी, 2006 से यथा पुनरीक्षित पूर्व 2006 पेंशनरों की पेंशन 6 फरवरी, 2015 से पूर्व पुनरीक्षित वेतनमान (O.M. No. 2/45/2009-1पेंशन दिनांक 30.03.2010 द्वारा यथा प्रतिस्थापित उच्चतर प्रशासकीय ग्रेड (एच.ए.जी.) वेतनमान सहित) जिससे पेंशनर सेवानिवृत्त हुआ था, के तत्स्थानी वेतन बैंड तथा ग्रेड वेतन में वेतन की न्यूनतम वेतन के 50% (पचास प्रतिशत) तक बढ़ाई जाएगी, जिस तरह से हरियाणा राजपत्र में प्रकाशित वित्त विभाग (वेतन पुनरीक्षण शाखा) के पत्र संख्या 1/83/2008-पी.आर.(एफ.डी.), दिनांक 07.01.2009 तथा वित्त विभाग, शुद्धि-पत्र, दिनांक 27 जनवरी, 2009 से संलग्न फिटमेंट तालिका के सन्दर्भ से प्राप्त की गई है। पूर्व 2006 पेंशनरों की पुनरीक्षित पेंशन अनुबन्ध-I के खाना संख्या 8 के अनुसार संगणित की जाएगी।

No. 2/45/2009-1पेंशन दिनांक 30.03.2010 द्वारा यथा प्रतिस्थापित उच्चतर प्रशासकीय ग्रेड (एच.ए.जी.) वेतनमान सहित) जिसमें सरकारी कर्मचारी सेवानिवृत्त हुआ था, के तत्स्थानी वेतन बैंड तथा ग्रेड वेतन में वेतन की न्यूनतम वेतन के 30% (तीस प्रतिशत) तक बढ़ाई जाएगी, जिस तरह से हरियाणा राजपत्र में प्रकाशित वित्त विभाग (वेतन पुनरीक्षण शाखा) के पत्र संख्या 1/83/2008-पी.आर. (एफ.डी.) दिनांक 07.01.2009 तथा वित्त विभाग, शुद्धि-पत्र, दिनांक 27 जनवरी, 2009 से संलग्न फिटमेंट तालिका के सन्दर्भ से प्राप्त की गई है। पूर्व 2006 पारिवारिक पेंशनरों की पुनरीक्षित पेंशन अनुबन्ध- I के खाना संख्या 9 के अनुसार संगणित की जाएगी।”
