1st, 2nd, 3rd, 4th, instalment of Interim Relief already paid vide this Department Office Memoranda No. Fin.(Pen)B(10)-6/98-III dated 02.08.2016, 04.08.2017, 09.02.2018, 20.08.2018 and twelve instalments of Dearness Relief sanctioned earlier vide Office Memoranda No. Fin (Pen) B (10)-6/98-III dated 03.10.2016, 07.04.2017, 11.09.2017, 08.01.2018, 30.10.2018, O.M. 

- 2. The Governor, Himachal Pradesh is further pleased to order that 20% of arrear of gratuity, in respect of Government servants, who had retired/ died in harness on or after 01.01.2016, shall be paid in the month of September, 2022.
- 3. 1st, 2nd, 3rd, 4th, instalment of Interim Relief already paid on the basic pension and basic family pension vide this Department's Office Memoranda No. Fin.
