Subject: - Grant of Dearness Relief to Himachal Pradesh Government Pensioners/Family Pensioners.

1. In continuation of this department's O.M. No. Fin (Pen)B(10)-6/98-IV-Loose dated 04th March, 2024, the Undersigned is directed to say that the Governor, Himachal Pradesh is pleased to decide that dearness relief @ 4% due from 01.01.2023 to the Government pensioners/family pensioners including AIS pensioners/family pensioners shall be paid by enhancing the existing rate from 38% to 42% from 01.10.2024.

2. The additional Dearness Relief shall be paid with the pension/family pension for the month of October, 2024. The decision on payment of arrears of dearness relief for the period 01.01.2023 to 30.09.2024 will be taken separately in due course of time.

3. Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

4. Other provisions governing grant of dearness relief to pensioners, such as, regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.

As dearness relief will be at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner alongwith the dearness relief orders. It will be the responsibility of the Pension Disbursing Authority (PDA), including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.

The Accountant General, (A&E) H.P., Treasury Officers and 6. authorized Public Sector Banks are requested to arrange the payment of Dearness Relief to pensioners on the basis of these orders.

1. In continuation to this Department's Office Memorandum No. Fin(Pen)A(3)-1/2021-Part-II-Loose dated 17-09-2022 and the Office Memoranda No.Fin(Pen)A(3)-1/2021-Part-II dated 13-03-2024 and 28-08-2024 on the subject cited above, the undersigned is directed to say that the Governor, Himachal Pradesh, is pleased to order that entire balance arrears @ 22.50% of the total pension/ family pension arrears shall be paid to the pensioners and family pensioners who have attained the age of 75 years and above, with the pension/family pension of October, 2024 payable on 28th October, 2024. Now, after issuance of these orders, the cumulative arrears paid to pensioners/family pensioners who have attained the age of 75 years and above, will be 100% of the total arrears. Hence, balance arrears of this category of pensioners/family pensioners would be Zero.

2. All the Pension Disbursing Authorities (PDA) including banks and all the Drawing and Disbursing Officers (DDO's) in the Govt. Departments will ensure that any extra amount of pension, family pension, gratuity and leave encashment, if recoverable, shall be adjusted from the arrears of pension/family pension being paid to them and only the balance amount is released.
