Sir,

I am directed to refer to your letter No. HHC/GAZ/10/35/2018-2019 dated 01.08.2018 on the subject cited above and to say that the matter was examined at Government level in consultation with the Finance Department. It has been observed that since there are Hon'ble. Supreme Court Orders to release IR @ 30% to Judicial Officers, the same need to be released for which FD has given its concurrence. The release, however, would be subject to adjustment of IR already drawn/paid in pursuance to various HP Government Orders on IR release. This IR release would be further adjusted against the ensuing revision of pay scales of Judicial Officers and revision of pension of retired Judicial Officers w.e.f. 01.01.2016, as ordered by Apex Court.

In view of the above, you are requested, on the administrative side to take further necessary action in the matter, accordingly.
