**OFFICE MEMORANDUM**

No.SERI-PEN-0004-16- 17449 /AIS.I., Bhubaneswar, dated 16<sup>th</sup> August, 2017

Sub: Implementation of Government's decision on the recommendations of the Seventh Central Pay Commission-Revision of pension of Pre-2016 pensioners/family pensioners of All India Service Cadre.

As per the recommendations of the 7<sup>th</sup> Central Pay Commission, the Government of India have issued regulations for revision of pension / family pension of all the pre-2016 AIS pensioners / family pensioners in the Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pension & Pensioners Welfare Office Memorandum F. No. 38/37/2016-P&PW(A)(ii) dtd. 04.08.2016 (Annexure-A) and subsequent modification vide OM of even number dtd.12.05.2017(Annexure-B).

2. It has been decided by Government of Odisha to adopt the provisions in the aforesaid Office Memoranda of the Government of India for revision of pension/family pension in respect of All India Service pre-2016 pensioners/family pensioners who were working in the affairs of the State and retired from Government service / died prior to 01.01.2016 as specified in the following paragraphs:

3. These orders shall apply to all All India Service pensioners/family pensioners who were drawing pension/family pension before 01.01.2016.

a) Existing pensioner or Existing Family pensioner means a pensioner/family pensioner to whom these orders are applicable in terms of para 2 above.

b) Existing pension or Existing family Pension means the basic pension (inclusive of commuted portion, if any) or basic family pension, as had been fixed at the time of implementation of 6<sup>th</sup> CPC recommendations, which an existing pensioner or family pensioner was entitled to.

**First option:**

4. The revised pension / family pension w.e.f. 01.01.2016 in respect of all All India Service pensioners/family pensioners who retired /died prior to 01.01.2016, may be revised by notionally fixing their pay in the Pay Matrix recommended by the 7<sup>th</sup> CPC in the level corresponding to the pay in the pay scale/pay band and grade pay at which they retired/died. This will be done by notional pay fixation under each intervening Pay Commission based on the formula for revision of pay. While fixing pay on notional basis, the pay fixation formulae approved by the Government and other relevant instructions on the subject in force at the relevant time shall be followed. 50% of the notional pay as on 01.01.2016 shall be the revised pension and 30% of the notional pay shall be the revised family pension w.e.f. 01.01.2016 as per the first Formulation as provided in O.M. dtd.12.05.2017(Annexure-B). In the case of family pensioners who were entitled to family pension at enhanced rate, the revised family pension shall be 50% of the notional pay as on 01.01.2016 and shall be payable till the period up to which family pension at enhanced rate is admissible as per rules. The amount of revised pension / family pension so arrived at shall be rounded off to next higher rupee.

### Second option:

5.1. For existing pensioners / family pensioners who have retired / died before 01.01.2016, the revised pension/family pension with effect from 01.01.2016 shall be determined by multiplying the pension/family pension, as had been fixed at the time of implementation of 6<sup>th</sup> Central Pay commission (CPC) recommendations, by 2.57. The amount of revised pension/family pension so arrived at shall be rounded off to next higher rupee as provided in OM No.38/37/2016 P & PW(A)(ii) dtd.04.08.2016 (Annexure-A).

#### **Illustration:**

##### **Case. I**

Pensioner 'A' retired at last pay drawn of Rs. 79,000 on 31<sup>st</sup> May, 2015 under the 6<sup>th</sup> CPC regime in the scale of Rs. 67000-79000/-.

1	Basic Pension fixed in 6 <sup>th</sup> CPC	39500

##### **Case. II**

Pensioner 'B' retired at last pay drawn of Rs. 4,000 on 31<sup>st</sup> January 1989 under the 4<sup>th</sup> CPC regime in the scale of Rs. 3000-100-1500-125-4500.

1	Basic Pension fixed in 4 <sup>th</sup> CPC	1940
2	Basic Pension fixed in 6 <sup>th</sup> CPC	12600

Provided that for this purpose existing pension/family pension will be the basic pension/family pension only without the element of additional pension available to the old pensioners/family pensioners of the age 80 and above.

5.2. The higher of the above two Formulations shall be granted to pre-2016 pensioners as revised pension / family pension w.e.f. 01.01.2016.

6. As per Department of Pension & Pensioners Welfare OM No. 45/86/97-P&PW(A) (iii) dated 10.02.1998 for revision of pension / family pension in respect of All India Service holder who retired or died before 01.01.1986, by notional fixation of their pay in the scale of pay introduced with effect from 01.01.1986. The notional pay so worked out as on 01.01.1986 was treated as average emoluments / last pay for the purpose of calculation of notional pension / family pension as on 01.01.1986. The notional pension / family pension so arrived at, was further revised with effect from 01.01.1996 and was paid in accordance with the instructions issued for revision of pension / family pension of pre-1996 pensioners / family pensioners in implementation of the recommendations of the 5<sup>th</sup> Central Pay Commission.

7. Accordingly, for the purpose of calculation of notional pay w.e.f. 01.01.2016 of those All India Service holder who retired or died before 01.01.1986, the pay scale and the notional pay as on 01.01.1986, as arrived at in terms of the instructions issued vide Department of Pension & Pensioners Welfare OM 45/86/97-P&PW(A) dated 10.02.1998, will be treated as the pay scale and the pay of the concerned Government servant as on 01.01.1986. In the case of those Government servants who retired or died on or after 01.01.1986 but before 01.01.2016, the actual pay and the pay scale from which they retired



or died would be taken into consideration for the purpose of calculation of the notional pay as on 01.01.2016 in accordance with para 4 above.

8. The minimum pension with effect from 01.01.2016 will be Rs. 9000/- per month (excluding the element of additional pension to old pensioners). The upper ceiling on pension/family pension will be 50% and 30% respectively of the highest pay in the Government. (The highest pay in the Government of India is Rs. 2,50,000/- with effect from 01.01.2016).

9. The pension/family pension as worked out in accordance with provisions of para 4 and 5 above shall be treated as 'Basic Pension' with effect from 01.01.2016. The revised pension/family pension dearness relief sanctioned from 01.01.2016 and shall qualify for grant of Dearness Relief sanctioned thereafter.

10. Since the consolidated pension will be inclusive of commuted portion of pension, if any, the commuted portion will be deducted from the said amount while making monthly disbursements.

11. The quantum of age-related pension/family pension available to the old pensioners/family pensioners shall continue to be as follows:-

Age of pensioner/family pensioner	Additional quantum of pension
From 80 years to less than 85 years	20% of revised basic pension/family pension
From 85 years to less than 90 years	30% of revised basic pension/family pension
From 90 years to less than 95 years	40% of revised basic pension/family pension
From 95 years to less than 100 years	50% of revised basic pension/family pension
100 years or more	100% of revised basic pension/family pension

The amount of additional pension will be shown distinctly in the pension payment order. For example, in case where a pensioner is more than 80 years of age and his /her revised pension in terms Para 4.1 above is Rs. 10,000 pm, the pension will be shown as (i) Basic pension = Rs. 10,000 and (ii) Additional pension = Rs. 2,000 pm. The pension on his/her attaining the age of 85 years will be shown as (i) Basic Pension = Rs. 10,000 and (ii) additional pension = Rs. 3,000 pm. Dearness relief will be admissible on the additional pension available to the old pensioners also.

12. Where the revised pension/family pension in terms of paragraph 4 & 5 above works out to an amount less than Rs. 9000/- the same shall be stepped up to Rs. 9000/- . This will be regarded as pension/family pension with effect from 1.1.2016.

13. The existing instructions regarding regulation of dearness relief to employed/re-employed pensioners/family pensioners, as contained in Department of Pension & Pensioners Welfare O.M.No.45/73/97-P&PW(G) dated 02.07.1999 as amended from time to time shall continue to apply.


14. No arrears on account of revision of pension/family pension on notional fixation of pay will be admissible for the period prior to 01.01.2016. The arrears on account of revision of pension/family pension in terms of above these orders would be admissible with effect from 01.01.2016. For calculation of arrears becoming due on the revision of pension/family pension on the basis of this OM, the arrears of pension and the revised pension/family pension already paid on revision of pension/family pension in accordance with instructions



contained in the Department of Pension & Pensioners Welfare OM No.38/37/2016-  
P&PW(A)(ii) dtd. 04.08.2016 shall be adjusted.

15. The Head of Department from which the All India Service holder had retired or was working last before his death and the office of the Accountant General (A&E), Odisha to revise the pension/ family pension of pre - 2016 pensioners/ family pensioners with effect from 01.01.2016 in accordance with these orders and to issue a revised pension payment authority. The Pension Sanctioning Authority would impress upon the concerned Head of Office for fixation of pay on notional basis and arrange to get the revised authority issued at the earliest. The revised authority will be issued under the existing PPO number would travel to the Pension Disbursing Authority through the same channel through which the original PPO had travelled.
