Subject: Implementation of Pilot project for submission of Fresh Pension Cases in Online Diary Management System (ODMS).

Sir/Madam,

Kindly refer to this Department's memo No. 2/2/2019-1Pension (FD) dated **08.02.2021** and **08.07.2021** wherein it was decided by the State Government that a pilot may be conducted **in the four districts** for submission of Fresh Pension Cases in Online Diary Management System (ODMS) for speedy finalization of pension case of Government employees. Further it was also decided that during the pilot run the fresh pension cases may be submitted both through **Online Diary Management System (ODMS) as well as in physical form.**

Accountant General (A&E) Haryana has now requested to extend the pilot run in **4 (four)** more Districts in Haryana for submission of Fresh Pension Cases in Online Diary Management System (ODMS).


After due consideration, State Government has decided to extend the pilot run in **4 (four)** more Districts, as per detailed given below, in Haryana for submission of Fresh Pension Cases of Government employees to the Accountant General (A&E) Haryana Chandigarh both through **Online Diary Management System (ODMS) as well as in physical form:-**


Further, the **Online Diary Management System (ODMS) should be integrated with Parivar Pehchan Patra (PPP).**





It is also requested to direct the concerned officer(s) of their office for compliance on the following points:-

1. The Online Diary Management System (ODMS) should be integrated with Parivar Pehchan Patra (PPP).
2. A workshop may be organized by Accountant General (A&E) Haryana Chandigarh with all concerned DDOs of the Districts in which pilot run is extended.
3. Accountant General (A&E) Haryana Chandigarh may explore to use the data/service of HRMS by integrating of ODMS with HRMS or through API, so that data may be auto populated in ODMS without manual intervention.
4. A Helpdesk may be provided to all TO/DDOs to discuss and resolve the issue of ODMS while sending new pension cases.
