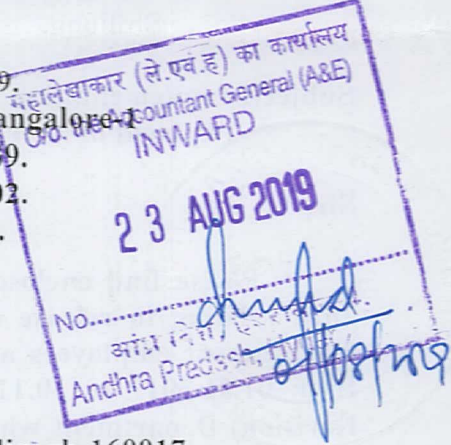


Sir,




