The next Incentive Examination for Sr. Auditor/ Assistant Supervisor is proposed to be held 23rd April 2024. The details of the scheme of the examination are given below: -

- 1. Sr. Auditors with one-year continuous service in the grade as on 01/04/2024 and Assistant Supervisors who have not passed the examination as Sr. Auditor will be eligible to appear in the examination.
- 2. There will be one paper on "Finance, Accounts and Audit" of 2 hours duration for 100 marks, 100 Multiple Choice Questions each correct answer carries 1 mark and each wrong answer carries -0.25 mark. The candidates have to write the examination in Hindi or English without the aid of books.
- 3. Candidates securing 50% (Fifty) percent marks and above would be granted one advance increment in their respective pay scale with effect from the first of the month in which the examination is held.
- 4. Officials who want to appear in the above examination shall send their application in the prescribed proforma (Attached with this circular) to the Confidential Cell on or before 2nd April 2024.
- 5. The application received after the last date or incomplete application will not be entertained in any circumstances.
