The Undersigned is directed to refer to this Department's Office Memorandum No.G.17011/6/2015-F.APF dt. 27.5.2015 enhancing Dearness Relief @ 119% and to convey that the Governor of Mizoram is pleased to grant enhancement of Dearness Relief @ 6% from the existing rate of 119% to 125% to the Government Pensioners and Family Pensioners with effect from 1.10.2016.

- 2. The Enhanced Dearness Relief @6% shall be paid in cash to all Pensioners/Family Pensioners of Government of Mizoram who continue to draw Pension/Family Pension.
- 3. Payment of Dearness Relief involving a fraction of Rupees shall be rounded off to the next higher rupee.
- 4. Payment of enhanced Dearness Relief should be made in Indian Rupee (INR).
