No. 2/14/2018-1Pension (FD) dated 02.01.2019, The Chief Secretary to Government of Haryana (Service III Branch) Chandigarh vide letter No. 28/35/2016-5SIII dated 4th January 2019 has intimated that in compliance of the order dated 27.03.2018 of Hon'ble Supreme Court of India, New Delhi passed in WP(C) No. 643 of 2015 along with report dated 09.03.2018 of Second National Judicial Pay Commission State Govt. accords sanction as under:

- (i) To grant interim relief @ 30% (Thirty Percent) of the basic pension/family pension drawn as on 31.12.2015 to the pre-2016 retired Judicial officer viz. Civil Judge (Jr. Division), Civil Judge (Sr. Division) and District Judges.
- (ii) The amount of interim relied as liable to be adjusted in the future determination/ revision of pension/family pension pursuant to the final report submitted by the commission.

(iv) The above benefit is admissible w.e.f. 01.01.2016.
