In continuation to Government Order No. 29-F of 2025 dated 27.01.2025, it is hereby ordered that Government Pensioners/Family Pensioners shall be paid Dearness Allowance as under:-

The arrears on account of additional installment of Dearness Allowance with effect from January, 2025 to May, 2025 shall be paid in cash in June, 2025 i. and shall form part of the monthly Pension/Family Pension from June, 2025

The payment on account of Dearness Allowance involving a fraction of a 11.

rupee shall be rounded off to the next higher rupee.

Other provisions governing the grant of Dearness Allowance on pension/family pension such as the regulations of Dearness Allowance 111. during employment/re-employment where more than one pension is drawn etc. and other provisions of the existing rules/orders (as are not in conflict with provisions of this Order), shall continue to remain in force.
