

Subject:- Grant of Dearness Relief to the retired Judges of Supreme Count/High Courts and family pensioners of such Judges- revised rates effective from 91.07.2022.

Sir.

I am directed to refer to this department's letter of even number dated 25th April, 2022 on the above subject and to say that consequent upon grant of further Dearness Relief (DR) on pension/family pension to the employees of Central Government and Central Autonomous Bodies vide Department of Pension & Pensioners Welfare's O.M. No. 42/7/2022- P&PW(D) dated 08.10.2022 (Copy enclosed), it has been decided that retired Judges of Supreme Court/High Courts and family pensioners of such Judges would be entitled to Dearness Relief on pension/family pension at the rate of 38% of the basic pension/family pension (including additional pension/ family pension) with effect from 1st July, 2022.

2. The payment on account of Dearness Relief involving a fraction of a rupee shall be rounded to the next higher rupee.

3. The provision governing grant of Dearness Relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., will remain unchanged.

- 4. Other provisions contained in this Department's letter No. L-19016/3/97-Jus. dated 13th January, 1999 will remain unchanged.
- 5. Accountant Generals/Pay and Accounts Officers are requested to arrange payment of dearness relief to the pensioners on the basis of the aforesaid instructions as per the procedure adopted by the Department of Pension & Pensioners' Welfare without any further delay.

OFFICE MEMORANDUM

Sub: Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 01.07.2022.

The undersigned is directed to refer to this Department's OM No. 42/07/2022-P&PW(D) dated 05.04.2022 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 34% to 38% w.e.f 01.07.2022.

- 2. These rates of DR will be applicable to the following categories:
 - i. Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
 - ii. The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates.
- iii. All India Service Pensioners
- iv. Railway Pensioners/family pensioners
- v. Pensioners who are in receipt of provisional pension
- vi. The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11.09.2017.
- 3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4. Other provisions governing grant of DR in respect of employed family pensioners and reemployed Central Government Pensioners will be regulated in accordance with the provisions contained in Rule 52 of CCS (Pension) Rules, 2021 and this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 5. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.

- 6. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 7. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 8. In so far as the persons serving in Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148(5) of the Constitution of India.
- 9. This issues in accordance with the Ministry of Finance, Department of Expenditure's OM No. 1/3/2022-E.II(B) dated 03.10.2022.

Subject:- Grant of Dearness Allowance (DA) to the Judges of Supreme Court and High Courts- Revised Rates effective from 1.7.2022.

Sir,

I am directed to refer to this Department's letter of even number dated 12th April, 2022 on the above subject and to say that Ministry of Finance, Department of Expenditure, vide O.M. No. 1/3/2022-E-II (B) dated 3rd October, 2022 (copy enclosed) has revised the rates of Dearness Allowance (D.A.) payable to Central Government employees and to the members of All India Services. The Dearness Allowance has been revised from 34% to 38% of the basic pay w.e.f. 01.07.2022. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.

- 2. By virtue of the provisions contained in Rule 2 of High Court Judges Rules, 1956 and Rule 6 of the Supreme Court Judges Rules, 1959, the Judges of the High Courts and Supreme Court are also entitled to the revised rates of Dearness Allowance w.e.f. 01.07.2022 at the same rates (38%) as are admissible to the members of All India Service. The admissibility of Dearness Allowance would be subject to other conditions as stipulated by Department of expenditure's above mentioned O.M.
- 3. This issues with the concurrence of Joint Secretary and Financial Adviser (Law) vide note No. 79 dated 19.10.2022 (e-file no. 3831) and approval of Secretary (Justice) vide note No. 82 dated 20.10.2022.

OFFICE MEMORANDUM

Subject: Revision of rates of Dearness Allowance to Central Government employeeseffective from 01.07,2022.

The undersigned is directed to refer to this Ministry's Office Memorandum No. 1/2/2022-E-II (B) dated 31.03.2022 on the subject mentioned above and to say that the President is pleased to decide that the rate of Dearness Allowance payable to Central Government employees, shall be enhanced from 34% to 38% of the Basic Pay with effect from 1st July, 2022.

- 2. The term 'Basic Pay' in the revised pay structure means the pay drawn in the prescribed Level in the Pay Matrix as per 7th CPC recommendations accepted by the Government, but does not include any other type of pay like special pay, etc.
- 3. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9(21).
- 4. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
- 5. These orders shall also apply to the civilian employees paid from the Defence Services Estimates and the expenditure will be chargeable to the relevant head of the Defence Services Estimates. In respect of Armed Forces personnel and Railway employees, separate orders will be issued by the Ministry of Defence and Ministry of Railways, respectively.
- 6. In so far as the persons serving in the Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148(5) of the Constitution of India.
