As per existing procedure, when Pension Payment Orders (PPOs) are issued to Treasuries in favour of differently abled persons, the name of the guardian is specified in the PPO through whom payment is to be made.

In reply to clarification sought for from this office regarding acceptance of limited guardianship certificate for continued payment of family pension to differently abled persons, Government Finance(Pension-B) Department have clarified that payment can be made on the PPO through guardian on production of guardianship certificate obtained for limited/unlimited period. Therefore, it is intimated that, henceforth, the name of the guardian will not be mentioned in the PPOs issued from this office in respect of differently abled persons for payment through guardian sanctioned based on limited guardianship certificate. The period of expiry of the guardianship certificate as per which the family pension is being authorized, will be noted in the PPO.

For continued payment of family pension beyond the expiry date of the guardianship certificate, fresh guardianship certificate may be obtained either for limited or unlimited period and also subject to the compliance of conditions as specified in G.O(P)No.59/2024/FIN dated 22/07/2024.
