Subject: Clarification on consideration of additional quantum of pension as a part of Basic Pension in determining the eligibility for ex-gratia payment.

It is informed that the Government of West Bengal, Finance Department, in their Pension Branch letter No. 102-FIN-45017/2/2022-PENSION SEC-Dept. of FIN dated 28/3/2025 has clarified with reference to Memo. No. 1492-F (P2) dated 6/5/2021 and subsequent Memos issued in this respect regarding payment of ex-gratia to the State Government Pensioners/Family Pensioners that:-

- Pension in determining the eligibility for ex-gratia payment for a year and the same would be shown distinctly. It is, therefore, decided that to determine the ceiling for payment of ex-gratia, it may be made on the consolidated amount of Basic Pension + Dearness Relief on (Basic Pension + Additional quantum of pension).
- (2) In case of Double pensioners, if the ceiling for ex-gratia is exceeded either for pension or family pension, then the other pension, be it pension or family pension, as the case may be, is not eligible for ex-gratia payment, although it falls below the ex-gratia ceiling for a particular year.

Since the order on relief contained in the above Government of Goa's Letter are applicable to Goa Government Freedom Fighters and Goa Freedom Fighter Family Pensioners under Freedom Fighter Welfare Rules, 2013, I am to authorize you to pay to the Goa Government Freedom Fighters Pensioners/Family Pensioners the installment of 2% of Dearness Relief raising it from 53% to 55% with effect from 01/01/2025.

3. In case of Goa State Freedom Fighters/Family Pensioners drawing pension in other States, the instructions contained in above Letter may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension.

4. This Dearness Relief is only applicable to the Goa State Freedom Fighter Pensioners/Family Pensioners.

5. Instructions issued from time to time by this office as regards to payment of relief should be observed.

 Wide Publicity may be given to this circular letter by displaying a copy on the office notice board or other permanent place in your office.

7. Pensioners who have drawn part payment of their pension through Treasury Office after 01/07/2016 and have subsequently opted for payment of their pension through Bank may also be paid arrears without waiting for any individual orders from this office.

#### MEMORANDUM

Subject: Release of further installment of 3% Dearness Relief w.e.f. 1st April, 2025.

The undersigned is directed to refer to the subject mentioned above and to state that the Governor of Tripura is pleased to decide grant of further installment of Dearness Relief @ 3% over the basic pension/ basic family pension as admissible under Tripura State Civil Services (Revised Pension) Rules, 2017 read with its 1<sup>st</sup> Amendment, 2018, with effect from 01-04-2025 to the State Government pensioners and family pensioners. With the release of this installment, total quantum of Dearness Relief payable to the State government pensioners and family pensioners with effect from 01-04-2025 shall stand at 33% (30% + 3%) over the basic pension/ family pension, as the case may be.

- 2. The payment on account of Dearness Relief involving fractions of 50 paisa and above may be rounded off to the next higher rupee and the fractions of less than 50 paisa may be ignored.
- 3. The Pension Disbursing Authorities including Public Sector Banks handling disbursement of pension/ family pension to the State Government Pensioners / Family Pensioners are authorized to calculate and disburse Dearness Relief at the above rate and manner in each individual case from 01-04-2025.
- 4. The expenditure on payment of Dearness Relief on pension/ family pension to the State Government Pensioners / Family Pensioners respectively shall be debitable to the Major Head '2071-Pension and other Retirement Benefits'.
