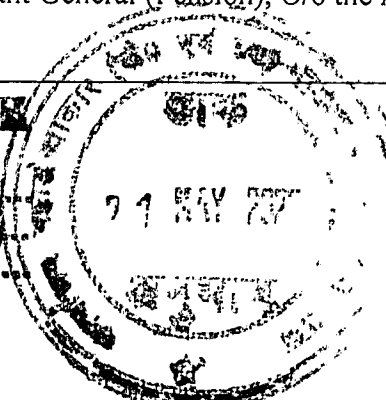

Sub : Payment of Dearness Allowance/ Dearness Relief to the serving State Government Employees/State Government Pensioners/Family Pension Holders/Extra Ordinary Pension Holders/Compassionate Family Pension Holders in revised rates effective from 01/01/2025, applicable for revised pay scale as per A.S.(ROP) Rules, 2017.

The undersigned is directed to refer to Finance Department's OM vide No. FEG.2498/2017/395 dated 04/11/2024 and to say that Governor of Assam is pleased to decide that the Dearness Allowance/Dearness Relief (D.A./D.R.) to the State Government employees and the pensioners who are entitled to draw pay & pension as per A.S. (ROP) Rules, 2017 shall be admissible as per rate shown below:

Period from which payable	Rate of D.A./D.R. enhanced	Rate of D.A./D.R. per mensem
From <u>01/01/2025</u>	2%	55% of Basic Pay/Basic Pension

Note :- The payment on account of D.A./D.R. involving fractions of 50 paise and above may be rounded off to the next higher rupee and fraction of less than 50 paise may be ignored.

- 1) The order shall apply to Government employees who are brought over to the revised scale of pay w.e.f. 01/04/2016 and to those who elected to retain the scale of pay that prevailed prior to 01/04/2016. In case of the former, pay for the purpose of D.A. will be as defined in F.R. 9(21)(a) (i) including stagnation increment. Those Government employees who exercised option to retain the scale of pay that existed prior to 01/04/2016 shall continue to draw the D.A. as is appropriate to the pay scales in force on 31/03/2016.
- 2) The amount sanctioned shall be classified as D.A./D.R. and the expenditure for the purpose will be debitable to the detailed head of Salary, Pension under respective head of account from which Government employees draw their pay and the Pensioners draw their pension.
- 3) (i) The enhanced rate of 55% D.A./D.R shall be paid along with monthly pay/pension for the month of **March, 2025 in April, 2025.**
(ii) The arrear D.A/D.R. with effect from **01/01/2025 to 28/02/2025** shall be paid in **two equal installments, first in the month of May, 2025 and the second in the month of June, 2025** through Bank Accounts of the Employees/Pensioners. The undersigned is directed to refer to Finance Department's OM vide No. FEG.2498/2017/395 dated 04/11/2024 and to say that Governor of Assam is pleased to decide that the Dearness Allowance/Dearness Relief (D.A./D.R.) to the State Government employees and the pensioners who are entitled to draw pay & pension as per A.S. (ROP) Rules, 2017 shall be admissible as per rate shown below:

Period from which payable	Rate of D.A./D.R. enhanced	Rate of D.A./D.R. per mensem
From 01/01/2025	2%	55% of Basic Pay/Basic Pension

Note :- The payment on account of D.A./D.R. involving fractions of 50 paise and above may be rounded off to the next higher rupee and fraction of less than 50 paise may be ignored.

- 1) The order shall apply to Government employees who are brought over to the revised scale of pay w.e.f. 01/04/2016 and to those who elected to retain the scale of pay that prevailed prior to 01/04/2016. In case of the former, pay for the purpose of D.A. will be as defined in F.R. 9(21)(a) (i) including stagnation increment. Those Government employees who exercised option to retain the scale of pay that existed prior to 01/04/2016 shall continue to draw the D.A. as is appropriate to the pay scales in force on 31/03/2016.
- 2) The amount sanctioned shall be classified as D.A./D.R. and the expenditure for the purpose will be debitable to the detailed head of Salary, Pension under respective head of account from which Government employees draw their pay and the Pensioners draw their pension.
- 3) (i) The enhanced rate of 55% D.A./D.R shall be paid along with monthly pay/pension for the month of **March, 2025 in April, 2025.**

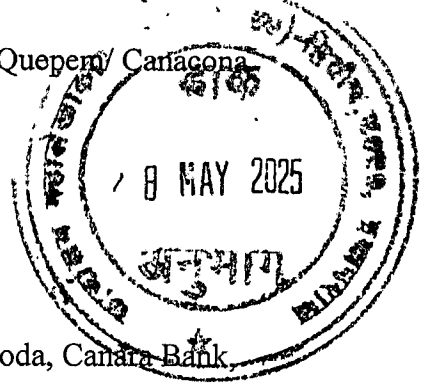

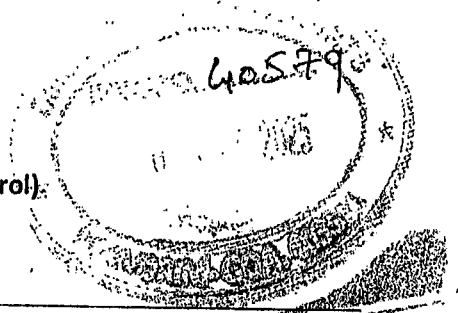

The copy of the said Office Memorandum is enclosed for information and necessary action.
2. Since the order on relief contained in the above Government of India's Office Memorandum is adopted and made applicable to the Goa Government Pensioners and Family Pensioners, I am to authorize you to pay to the Goa Government Pensioners/Family Pensioners enhanced Dearness Relief @ 55% from existing 53% with effect from 01/01/2025.
The Dearness Relief @ 55% is to be paid to the Pensioners w.e.f. 01/01/2025 and is to be released alongwith the arrears from 01/01/2025 to 30/04/2025, in the monthly pension payable from month of May, 2025. It is also applicable to the following pensioners.
 - (a). Ex-gratia pensioners (Montepio pensioners, pensioners drawing pensions on account of service rendered to Portuguese colonies and institute Ultramarine Pensioners) drawing pensions under C/B/D and E series.
 - (b). Pensao de Sanguie pensioners.
 - (c). Pensioners receiving pension under triple benefit scheme.
 - (d). Recipients of Ex-gratia i.e. Families of deceased pensioners/employees who were governed under EFU.
 - (e). Pensioners sanctioned pension under Education Act 15 of 1985 and drawing pension under pension payment series T and E.B.
3. In case of Goa State Government Pensioners drawing pension in other States, the instructions contained in above Office Memorandum may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension.
4. This Dearness relief is not applicable to the following class of pensioners.

2. These rates of DR will be applicable to the following categories:-

- (i) Civilian Central Government Pensioners/ Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D) Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
- (ii) The Armed Forces Pensioners/Family Pensioners and Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates.
- (iii) All India Service Pensioners/Family Pensioners.
- (iv) Railway Pensioners/Family Pensioners.
- (v) Pensioners who are in receipt of provisional pension.
- (vi) The Burma Civilian Pensioners/Family Pensioners and Pensioners/ families of displaced Government pensioners from Burma/Pakistan, in respect of whom orders have been issued vide this Department's O.M. No.23/3/2008-P&PW(B) dated 11.09.2017.

3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

4. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in Rule 52 of CCS(Pension) Rules, 2021 and this Department's O.M. No.45/73/97-P&PW(G) dated 2.7.1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.

5. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.

6. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.

7. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of Dearness relief to Pensioners/Family Pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No.528-TA,II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No.GANB No.2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.

8. In so far as the persons serving in Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148 (5) of the Constitution of India.

10. This issues in accordance with the Ministry of Finance, Department of Expenditure's O.M. No.1/1/2025-E.II(B) dated 02.04.2025.
