*The revenue deficit and fiscal deficit have been reduced by ₹16,135 crore and ₹19,350 crore respectively compared to the February 2025 accounts. This is primarily due to the transfer of ₹19,685 crore from the Public Account to the Revenue Account (₹16,700 crore), Loans and Advances (₹1,482 crore) and increase in Tax Revenue (₹947 crore).*
