विषय:- माननीय भूतपूर्व म.प्र. विधान सभा सदस्यों को पुनरीक्षित दर से पेंशन/परिवार पेंशन एवं चिकित्सा भत्ता के भुगतान हेतु।

उपरोक्त विषयान्तर्गत म.प्र. राजपत्र (असाधारण)/186, दिनांक 22.04.2016 में प्रकाशित म.प्र. विधान सभा सदस्य वेतन भत्ता तथा पेंशन संशोधन अधिनियम 2016 के अनुसार म.प्र. विधान सभा के भूतपूर्व सदस्यों की न्यूनतम पेंशन में रु. 5000/- प्र.मा., परिवार पेंशन में रु. 8000/- प्र.मा. एवं चिकित्सा भत्ता में रु. 5000/- प्र.मा. की वृद्धि की गई है। इसके साथ ही बस यात्रा भत्ता समाप्त कर दिया गया है। भूतपूर्व सदस्यों को उनकी पात्रता अनुसार पुनरीक्षित पेंशन, परिवार पेंशन एवं चिकित्सा भत्ता दिनांक 22.04.2016 से प्रभावशील होगा। अतः दिनांक 22.04.2016 से न्यूनतम पेंशन रु. 15,000/- के स्थान पर रु. 20,000/- प्र.मा. देय है एवं प्रत्येक पांच वर्ष के ऊपर अतिरिक्त वर्ष की सेवा के लिये रु. 500/- के स्थान पर रु. 800/- प्र.मा. देय है। चिकित्सा भत्ता वर्तमान दर रु. 10,000/- के स्थान पर रु. 15,000/- प्र.मा. देय है। परिवार पेंशन रु. 10,000/- के स्थान पर रु. 18,000/- प्र.मा. की पात्रता है। अधिनियम के अनुसार पेंशन की पुनरीक्षित दर निम्नानुसार देय होगी:-

Sub : Payment of pension/family pension and medical allowance to the Honourable former members of M.P. Legislative Assembly at revised rate - reg.

Ref : Letter no. 310/Vi.Sa./Sa.Le./16, Bhopal dated 05.05.2016 of the Secretariat.

On the above cited subject, as per the Salary, Allowances and Pension Revision of Members of M.P. Legislative Assembly Act, 2016 published in the M.P. Gazette (Extra Ordinary)/186, dated 22.04.2016, an increase of Rs.5000/- p.m in the minimum pension, Rs.8000/- p.m. in the family pension and Rs.5000/- p.m. in the medical allowance of former members of M.P. Legislative Assembly has been made. Along with this, bus travel allowance has been abolished. Revised pension, family pension and medical allowance shall be admissible to the former members from 22.04.2016, as per their eligibility. Therefore, from 22.04.2016 minimum pension Rs.20000/- p.m. is payable in place of Rs.15000/- and for every additional year of service above each five years, Rs.800/- p.m. in place of Rs.500/- is payable. Medical allowance of Rs.15000/- p.m. shall be payable in place of existing rate of Rs. 10000/-. Eligibility of family pension is Rs.18000/- p.m. in place of Rs.10000/-. As per the Act, revised rate of pension shall be payable as below :-
