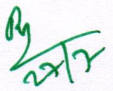

Pursuant to Government Resolution of even number dated 26.02.2026, the rate of Dearness Relief admissible to State Government Pensioners / Family Pensioners has been revised from 55% to 58%. Accordingly, a decision was taken to pay the said Dearness Relief in cash with effect from February 1, 2026, and to pay the arrears for the period from July 2025 to October 2025 in cash in the month of March 2026. Furthermore, it was decided that separate orders would be issued regarding the arrears for the remaining period (November 2025 to January 2026).

In line with this, the matter of paying the arrears for the remaining period to the State Government Pensioners / Family Pensioners was under the consideration of the Government.

Resolution

Government is pleased to decide that amount of Dearness Allowance arrears for the period from November 1, 2025, to January 31, 2026, shall be paid in cash along with the pension for May 2026 to the State Government Pensioners / Family Pensioners drawing pension / family pension under the revised pay structure (as per the 7th Pay Commission).

2. It will be the responsibility of the Pension Disbursing Authority, i.e. Pay and Accounts Officer, Mumbai/Treasury Officers, as the case may be, to calculate the quantum of dearness relief payable in each individual case.
3. Government is also pleased to direct that above decision should mutatis mutandis, apply to those pensioners including family pensioners of Recognised and Aided Educational Institutions, Agricultural / Non-Agricultural Universities and Affiliated Non-Government colleges to whom the pension scheme is made applicable
4. In exercise of the powers conferred by the proviso to Section 248 of the Maharashtra Zilla Parishads and Panchayat Samitis Act, 1961 (Mah.V of 1962) and of all the other powers enabling it in that behalf. Government is further pleased to decide that the above decision shall apply to the pensioners including family pensioners of Zilla Parishads.
5. The expenditure on this account should be debited to the Budget Heads to which the retirement benefits of the employees mentioned in the above paras are debited and should be met from the grants sanctioned thereunder.

6. All orders in force in regard to the payment of relief on pension sanctioned by Government.
