Government is also pleased to direct that above decision should mutatis mutandis, apply to those pensioners including family pensioners of Recognised and Aided Educational Institutions, Agricultural / Non-Agricultural Universities and Affiliated Non-Government colleges to whom the pension scheme is made applicable.
5. In exercise of the powers conferred by the proviso to Section 248 of the Maharashtra Zilla Parishads and Panchayat Samities Act, 1961 (Mah.V of 1962) and of all the other powers enabling it in that behalf, Government is further pleased to

Government Resolution –

According to the Government Resolution under reference above, the rate of dearness relief of State Government pensioners / family pensioners, who draw their pension in the pre-revised scale (As per Sixth Pay Commission) has been enhanced from 148% to 154% with effect from 1st January, 2019, and had been in cash from 1st July 2019.

2. Government is pleased to decide that the State Government pensioners /family pensioners who draw their pension in the pre-revised scale (As per Sixth Pay Commission) will get arrears of Dearness Relief of the six months for the period of 1st January, 2019 to 30th June, 2019 in cash along with pension / family pension of the month of January 2021.
3. It will be the responsibility of the Pension Disbursing Authority, i.e. Pay and accounts Officer, Mumbai/Treasury Officers, as the case may be, to calculate the quantum of dearness relief payable in each individual case.
4. Government is also pleased to direct that above decision should mutatis mutandis, apply to those pensioners including family pensioners of Recognised and Aided Educational Institutions, Agricultural / Non-Agricultural Universities and Affiliated Non-Government colleges and to whom the pension scheme is made applicable.
