

RESOLUTION:

The State Government has decided to grant Medical Allowance of Rs.300/- per month to employees as well as pensioners of the State Government and Panchayat vide GR mentioned at (4) above. The revision of the existing rate of Medical Allowance was under consideration of the Government.

After careful consideration, The Government is pleased to revise the existing rate of Medical Allowance Rs.300/- per month to Rs.1000/- per month with the following conditions:

- 1) These orders shall be applicable to pensioners of the State Government/Panchayats.
- 2) These orders shall be applicable to Work charged pensioners.
- 3) Other provisions of the G.R.F.D. dated: 03/10/2012 shall continue to be applicable.
- 4) Accounting system and other conditions regarding granting option shall be as per the Medical Treatment Rules, 2015 of Health and Family Welfare department.
- 5) These orders shall be implemented with effect from date: 01/10/2022.
