

No.F(PR)-53/2017/33. - In partial modification to Para. 2 of this Department's O.M. No.F(PR)-53/2017/30, dated 20th December, 2019, the Governor of Meghalaya is pleased to order release of 100% of the arrear Dearness Allowance/Dearness Relief to all State Government employees/pensioners and family pensioners with immediate effect.

OFFICE MEMORANDUM

Subject:- Dearness Allowance/Dearness Relief.

No.F(PR)-53/2017/30. - The undersigned is directed to refer to this Department's O.M. No.F(PR)/53/2017/27, dated 30th May, 2019 and to say that the Governor of Meghalaya is pleased to decide that the Dearness Allowance/Dearness Relief payable to all categories of State Government employees/pensioners and family pension holders shall be enhanced from the existing rate of 7% to 12% with effect from 1st July, 2019.

2. 50% of the arrears for the months of July to December, 2019 shall be released immediately. The remaining 50% shall be released in due course.
3. These orders shall also apply to the members of the work-charged establishment and casual workers, other than Bungalow Peons, holding posts in the pay levels as admissible to the employees of corresponding categories under the regular establishment/services/posts.
4. The Dearness Relief under these orders shall remain suspended if the pensioners/family pensioners are employed/re-employed under the State/Central Government or employed/re-employed/permanently absorbed in the State's or Central Government's Company, Corporation, Undertaking or Autonomous Body. It shall, however, be revived after the spell of such employment/re-employment.
5. The payment on account of Dearness Allowance/Dearness Relief involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
6. The payment on account of the Dearness Allowance/Dearness Relief sanctioned herein shall be debited to the respective heads of accounts from which the employees draw their salary and the pensioners/family pension holders, their pension.
