- 6. The Committee has taken into consideration the following documents before considering the application for compassionate appointment and arriving at a conclusion.
 - a) GoI OM vide F. No. 14014/1/2022-Estt. (D) dated 02-08-2022.
 - b) Headquarters Circular No. 14 (No. 52-Staff Entt (Rules)/AR/02-2021) dated 20-04-2022.
 - c) Headquarters letter No. 130-Staff Entt (Rules)/AR/02-2021 dated 24-08-2022.
 - d) Financial enquiry / verification report of the applicant.
- 7. The Committee has carefully considered the application for compassionate appointment, and other associated records and unanimously recommends the following:

"That the object of the scheme is to grant appointment on compassionate grounds to a dependent family member of a Government servant dying in harness thereby leaving his family in penury and without any means of livelihood, to relieve family of the government servant concerned from financial destitution and help it to get over the emergency. The deceased government servant in this case was holding the post of Assistant Supervisor and was at the time of death drawing a basic pay of Rs. 72,100/-. Consequent upon his death the family of the deceased would receive a sum of Rs. 21,34,283/- as terminal benefits alongwith family pension of Rs. 36,050/- (at enhanced rate from 29-11-2021 to 28-11-2031) and Rs. 21,630/- (at ordinary rates). Moreover, the family is left with immovable property (plot and ready built house) having estimated valuation of Rs. 17,23,575/-. Furthermore, the wife of the deceased is also employed with the State Government under Education department and draws a monthly salary of Rs. 50,009/-. The family does not have any financial liability now as noticed by the committee. The family has one differently abled daughter (90% locomotor) on which it states to have expenditure of Rs. 15000/-In terms of Annexure V (ii) of Headquarters circular No. 14 dated 20-04-2022 total marks obtained by the applicant is 65 (enclosed Annexure II).

Hence, after careful consideration of all the facts of the applicant and the Committee's report it is reasonably found that the family of the deceased is not found convincingly to be in any economic distress or in need of any immediate financial assistance and therefore recommends that the case is **not fit** for appointment on compassionate grounds."
