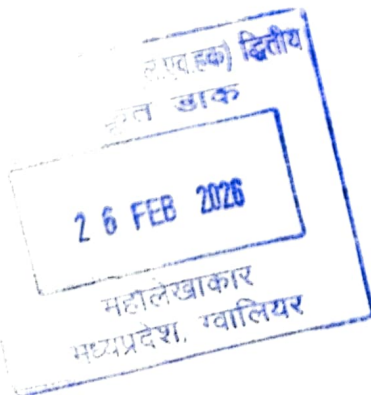

OFFICE MEMORANDUM

Subject: Increase of Dearness Relief from 40% to 44% to the Mizoram Government pensioners/ family pensioners with effect from 01.11.2025.

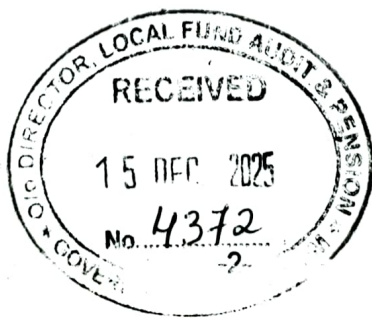
The undersigned is directed to convey sanction of the Governor of Mizoram for enhancing Dearness Relief @ 4% from the existing rate of 40% to 44% to the pensioners and family pensioners under the Government of Mizoram with effect from 01.11.2025.

- 2. The Enhanced Dearness Relief @4% shall be paid in cash to all pensioners/ family pensioners of Government of Mizoram who continue to draw pension/ family pension.
- 3. Payment of Dearness Relief involving a fraction of rupees shall be rounded off to the next higher rupee.
- 4. Payment of enhanced Dearness Relief should be made in Indian Rupee (INR).
- 5. The rate of Dearness Relief is to be enhanced by 2% from the rate of 44% with effect from 01.04.2026.
