- The initial period of deputation will be of one year and may be extended thereafter subject to his/her continued suitability and administrative convenience. The deputation will be governed by the terms and conditions laid down in Hqrs. Office Circular No. 900/GE II/59-2002 dated 12.08.2002 and Government of India, Ministry of Personnel, Public Grievances and Pensions O.M. No. 6/8/2009-Estt(Pay II) dated 17.06.2010 and subsequently amended from time to time.
- Panel upto panel year 2024 regarding promotion of eligible Asstt. Audit Officers to the post of Sr. Audit Officer (Civil) is pending for approval with Hqrs. office / Union Public Service Commission. On approval of the panel and promotion of eligible AAO to the post of Sr. Audit Officer (Civil), the Sr. Audit Officer taken on deputation may be repatriated to his/her parent office if no vacant posts are available in the cadre of Sr. Audit Officer (Civil) at that time.
- The officers working on deputation basis shall not have right for absorption in any post in this office.
