Apart from these the Government of Nagaland, Department of Finance ROP Cell O.M. 3. The Principal Accountant-General (A&E), Nagaland, is requested to circulate this O.M. to the Accountant General of all States so that Pensioners of the Government of Nagaland drawing pensions under their jurisdiction may be authorized for payment of this relief at the earliest.
