Subject to eligibility, their pay in Level-10 of 7th CPC Pay Matrix will be fixed under Rule 13 of CCS (Revised Pay) Rules 2016, notified vide Gazette Notification G.S.R. 721(E) F. No. 1-2/2016-IC dated 25.07.2016. They may exercise the option for fixation of pay on promotion within one month from the date of promotion.

As per Recruitment Rule for the post of Senior Divisional Accounts Officer in Part-II, Section 3, Sub-section (i) of Gazette of India vide GSR No. 10 dated 17.01.2020 published in Gazette of India on 25.01.2020, on their promotion, Senior Divisional Accounts Officer will be on probation for a period of 2 (two) years followed by confirmation.

This promotion is subject to judgement passed by the Hon'ble Supreme Court of India dated 26.09.2018 in SLP (C) No. 30621/2011.
