The trainees are also advised not to remain absent from training classes during the period of training without sufficient and genuine reason thereof, failing which such absence shall be noted in their APAR. Further, late attendance shall not be condoned as per the orders of the Accountant General dated 01.12.2019.

If the nominated trainees are unable to attend the training due to emergency/ medical grounds they must inform the same immediately to his/her controlling authority as well as intimate Admn.I Section. Branch officers should initiate necessary action to replace the nomination to avoid slot unutilization. Nomination of substitutes other than those from the Reserved Candidates list should be made with approval of the Accountant General.

The Branch officers of the Wing Headquarters are also requested to bring the contents of this office order to the notice of the selected trainees posted under them and also nominate the candidates posted under them at SAI Portal.

The concerned AMGs have to immediately take up the matter and inform the candidate as well as the RTI/Training institutes' authorities, the name of reserve candidate to avoid non-utilisation of slots.

In view of the above, any case of absence from training should be immediately informed to Admin-I wing along with reasons/leave application and supporting documents for further administrative action.
