- 1. The retired personnel would initially be engaged for a period of one year, extendable up to a maximum of 05 terms or the age of 65 years, whichever is earliest.
- Remuneration and allowances payable will be governed by GoI MoF OM No. 3-25/2020-E. IIIA dated 09.12.2020.
- No increment and Dearness Allowance shall be allowed during the term of the contract and no HRA shall be admissible.
- 4. An appropriate and fixed amount as 'Transport Allowance' for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.
- 5. Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year shall not be allowed. However, absence during curfew, bandh, strike, lockdown shall be dealt with in a similar way as in the case of serving officials.
- The appointment will be purely on temporary basis and is subject to termination at any time.
- 7. Retired officers selected to be hired on Short Term Contract Basis shall sign an agreement of confidentiality containing a clause on ethics and integrity.

Retired officers who are willing to be considered for the above assignment are required to submit their bio-data in the enclosed proforma and enclose copies of their APARs for last five years, if available with them.
