## OFFICE ORDER

In pursuance to Para 9.3.5 of Chapter 9 (revised upto 05.11.2013) of C&AG's MSO (Admn) Vol- I, AAOs/Sr. AOs who pass the Revenue Audit (RA) Examination would be granted one advance increment with effect from first of the month in which the examination is held.
