In pursuance to the Revised guidelines for Home Isolation of mild /asymptomatic COVID-19 cases issued by the Ministry of Health and Family Welfare, New Delhi on 05.01.2022, a patient under home isolation will stand discharged and end isolation after at least 7 days have passed from testing positive and no fever for 3 successive days and they shall continue wearing masks. There is no need for re-testing after the home isolation period is over.
