The grant of the advance is subject to the following terms and conditions:-

- (a) The purchase shall be completed and payment made within one month from the date on which t Government servant concerned draws the advance failing which he shall refund forthwith the full amount advance drawn together with interest on that amount for one month. He shall submit the cash receipt within o month from the date of drawal of advance.
- (b) The amount of advance shall be recovered in instalments as detailed below commencing with the fill issue of pay and/or leave salary or subsistence allowance after drawal of advance.

The interest accrued thereon shall be recovered in further instalments commencing from the mon immediately following that in which the repayment of advance for the purchase of personal computer is complete. The balance amount of advance, if any and wherever applicable, together with interest thereon shall be recovered from DCRG.

- (c) The rate of interest shall be as prescribed by the Govt. of India i.e. 12.3% per annum. If conditionattached to the sanction including those relating to the recovery of the amount are fulfilled completely to the satisfaction of the Competent Authority, a rebate of interest to the extent of 2½% will be allowed.
- (d) If the Government servant concerned ceases to be in service for any reason other than normal retireme superannuation or dies before payment of the advance in full, the entire outstanding amount shall become payab to the Govt.
- (e) Furnishing of false certificates will render him liable to suitable disciplinary action apart from beir called upon to refund forthwith the entire amount of advance disbursed to him together with the amount of interes

The grant of the advance is subject to the fulfilment of the usual conditions under the "RULES T REGULATE THE GRANT OF ADVANCE TO CENTRAL GOVT. SERVANTS FOR PURCHASE C PERSONAL COMPUTER" as amended from time to time.

The amount of advance is adjustable under the "Head 7610 - Loans to Govt. Servant (Other than HBA)".
