Office of the Director General of Audit, Environment & Scientific Departments, New Delhi has communicated the approval of the Competent Authority for grant of financial up-gradation under MACP Scheme to the following official of this office with effect from the date as shown against his name.

The aforesaid official has been granted financial up-gradation under the Modified Assured Career Progression Scheme subject to the following conditions:-

- i) Grant of financial up-gradation under the MACP Scheme shall only be on personal basis and shall not tantamount either to functional/regular promotion or to change in the existing designation/status of the concerned official. It will also not change the existing seniority position thereof. However, financial and certain other benefits, which are linked to the pay drawn by an employee, shall be permitted. No stepping up of pay in the pay level would be admissible with regard to junior getting more pay than the senior on account of pay fixation under the MACP Scheme.
- ii) With regard to fixation of pay on grant of financial upgradation under the MACP Scheme, the concerned official may exercise an option for pay fixation under Rule 10 of Central Civil Service (Revised Pay) Rules, 2016 read with clarification of Department of Expenditure's Office Memorandum No.- 4-21/2017-IC/E.IIIA dated 28.11.2019. In case of an official getting two or more financial upgradations, his/her pay shall be fixed successively in each level of pay matrix.
- iii) There shall be no further fixation of pay at the time of regular promotion, if it is in the same Level of Pay Matrix as granted under MACPS. However, at the time of actual promotion, if it happens to be in a post carrying higher Level of Pay Matrix than what is available under

MACPS, no pay fixation would be granted and any increase of pay level would be made available.

iv) In case the concerned official, after being granted financial up-gradation under the MACP Scheme, refuses the regular promotion subsequently, he/she shall not be eligible to be considered for further financial up-gradation, if admissible till he/she agrees to be considered for promotion again. The next financial up-gradation, if admissible shall also be deferred to the extent of period of debarment due to such refusal.
