Subject: Functioning of Online Diary Management System (ODMS) of Haryana.

Sir,

This is in continuation to this office letter no. Pen.1/ODMS/2021-22/1187 dated 12.01.2022 the subject cited above, vide which it was intimated to Additional Chief Secretary to Government of Haryana, Finance Department, Chandigarh that Accountant General Haryana (Online Diary Management System) ODMS website was hacked on 28th December 2021. Resultantly, all functionalities including authorization of Pension/Final Payment Cases of GPF stopped.

Now, ODMS has started functioning w.e.f 24th January 2022. Meanwhile, to ensure that pensioners/G.P.F subscribers do not face any undue hardship, this office has decided that all the Fresh Pension/Family pension cases/Pension Revision cases 7th CPC as per Haryana Government notification dated 10.0.2018 and 27.05.2019 and Final Payment Cases (GPF) which are received in the office of the Accountant General (A&E), Haryana offline i.e in physical form in this office till 14th February, 2022 will be processed and the same will be authorised by this office. From 15th February, 2022 onwards this office will return the case that are received offline i.e in physical form and only online cases will be processed.

Therefore, it is requested to issue necessary instructions to all the DDOs/PSAs under your control to submit the Fresh Pension/Family pension cases/Pension Revision cases 7th CPC as per Haryana Government notification dated 10.0.2018 and 27.05.2019 and Final Payment Cases (GPF) online w.e.f 15th February, 2022.

This may be treated as Most Urgent.
