In inviting a reference to your letter No-PA-1Ch.5/P/20Govt/60988784/Odisha/60936094 dated 02/02/2021 on the subject cited above, I am to state that Govt. of Odisha, Finance Department vide OM No-30260/FIN-TRY-MISC-0017-2016/F dated 13/11/2020 has issued an order regarding relaxation of the provision for submission of physically signed print copy of Pension Revision Application by Pensioners/Family Pensioners to the Pension Disbursing Authority (Treasury/Bank Branch). The copy of the said OM has been endorsed to all Accountant General (A&E) Offices in the next memo.

In this context, it is to mention here that the above OM is meant for all Pension Disbursing Authorities i.e. Treasuries/Spl. Treasuries/Sub- Treasuries/Public Sector Banks which are functioning in the State of Odisha and processing the pension revision applications of pensioners /family pensioners of pre-2016 through 'ARPANA' portal. As such, this office did not issue the said Office Memorandum under Special Seal Authority to all Accountant General (A&E) Offices for circulation among Pension Disbursing Authorities.
