Kindly refer the circular No. 3/2/92-Fin(Exp)/Part File-IV dated 16th November, 2022 issued from the office of the Government of Goa, Finance (Expenditure) Department Secretariat, Porvorim-Goa, has conveyed the sanction for revision of Dearness allowance to the employee of State Government and its Autonomous bodies who continue to draw their pay and allowances in the pre-revised scale as per the **6th Central Pay Commission**.

As per the said circulars dated 12/10/2022 Government of Goa has decided to 'EXTEND' the office memorandum No.1/3(1)/2008-E-II(B) dated 12th October, 2022 of Dearness allowance which is issued by Finance (Expenditure) department from time to time for the employees of State Government and its Autonomous bodies who continue to draw their pay and allowance in the pre-revised scale as per the **6th Central Pay Commission**.

It may be noted that in order to resolve the hardship being faced by the pensioner of Autonomous bodies/Corporations, it has been decided by the Government vide its order No.1/3(1)/2008-E-II(B) dated 07th April, 2022 to extend the office memorandum of Dearness allowance which is issued by Finance (Expenditure) department from time to time for the employees of State Government and its Autonomous bodies who continue to draw their pay and allowance in the pre-revised scale as per the **6th Central Pay Commission**, for grant of Dearness Relief to pensioners of the Autonomous bodies/Corporations who are in pre-revised pension s per 6th Central Pay Commission, under their administrative control.
