No. F.1(6)FD/Rules/2012

Sub: Amendment in the Rajasthan State Pensioners' Medical Concession Scheme, 2009

The Governor is pleased to make the following amendments in the Rajasthan State Pensioners' Medical Concession Scheme, 2009, namely :

In the said Scheme -

- (1) the existing para 6(1)(b) along with 'Exception' shall be deleted.
- (2) the existing para 7 shall be substituted by the following namely :-

Pensioners Medical Dairy / Smart Card :

- (i) Every Pensioner / Family Pensioner shall be issued Medical Dairy by the Treasury Officer / Treasury Officer (Pension) concerned free of cost.
- (ii) In the case of loss of original Medical Dairy, the Treasury Officer / Treasury Officer (Pension), shall issue a duplicate medical diary on payment of Rs. 100/- (Rupees one hundred only) after taking an undertaking from the concerned pensioners giving details of the amount upto which he has already taken medicines free of cost upto the date of the undertaking. He shall also give an undertaking to the effect that in case it is found that he has utilized both the original and duplicate medical diaries for the purpose of taking medicines free of cost, he will be permanently debarred from the medical facilities admissible under the Pensioners Medical Concession Scheme."

- (3) Para 9 (A)(1) shall be substituted by the following, namely :-
"(1) In case a pensioner / family pensioner is drawing his / her pension in other State, a fixed medical allowance @ Rs. 300/- per month shall be payable to him / her provided that he / she is not availing the medical facility available under the Scheme."

- (4) In para 10 the existing words "alongwith the amount of membership fee" shall be deleted.
- (5) In PMF 6 and 7 the existing entry at S.No. 12 shall be deleted.
- (6) In PMF 6 the existing entry at S.No. 1 appearing under heading " For use in the Office of the Member Secretary cum Director Pension and Pensioner's Welfare, Rajasthan Jaipur" shall be deleted and the existing entries thereunder at S.No. 2 and 3 shall be renumbered as S.No. 1 and 2 respectively.

- (7) In PMF-7 the existing entry at S.No. 1 appearing under heading "For use in the Office of the Treasury Officer....." shall be deleted and the existing entries thereunder at S.No. 2 and 3 shall be renumbered as S.No. 1 and 2 respectively

This order shall come into force w.e.f. 01.04.2012.

Sir,

Under the subject cited, the employees retired from the offices of the Government of Rajasthan who after their retirement have gone to reside in their home districts situated in other states and whose PPOs issued by the Pension Department are forwarded through your office and pension is being drawn by those pensioners from the Treasuries situated in the respective home districts.

As per Order No. **F.1(6) FD/Rules/2012 dated 24 April 2012** (copy attached), Medical Allowance of Rs.300 per month is payable to the aforesaid type of pensioners.

Therefore, for the civil pensioners of Rajasthan State located outside the State of Rajasthan, directions may be issued to the Treasury Officers to take action accordingly.
