Hence necessary instructions may be issued to to all Treasuries/subtreasuries/banks to recover Rs.1800/- in one lumpsum from the Tamil nadu Government Pensioners towards pensioners New Health Insurance Scheme subscription and forward the same to Director of Treasuries & Accounts, Panagal Building, Saidapet, Chennai 600 015 along with the duly filled Annexure IV enclosed herewith.
