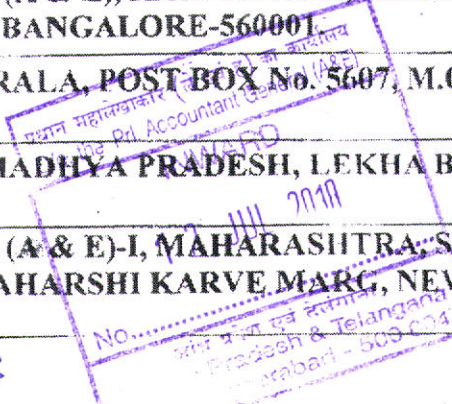

Sub- Procedure for submission of offline application for revision of pension in respect of pensioners/family pensioners of the state of Odisha, who are drawing pension/family pension in other states under the SSA-reg.

Sir,

In inviting a reference to the subject cited above, it is to state that the Govt. of Odisha, Finance Department vide OM No-Pen-200/2017/28300/F dated 23.09.2017 has revised pension/family pension of state Govt. Pensioners/Family Pensioners as per the recommendations of 7th CPC. The above OM was issued to your office vide this office letter No.-P.M.-1-10-1-state/Odisha/SSA/2017-18/428 (34) dt.12.10.2017 under Special Seal Authority for circulation among all Pension Disbursing Authorities. Accordingly, Pension Disbursing Authorities (PDAs) of some States have revised pensions/family pensions at their level in consolidated rate in accordance with the instructions of above OM. However, this office has received a number of complaints from the pensioners/family pensioners of the Govt. of Odisha who are drawing pension/family pension in other states under Special Seal Authority (SSA) that their pensions/family pensions are not revised so far due to ambiguities/misinterpretation of the above OMs.

Further, Govt. of Odisha, Finance Department for smooth, quick and hassle free disposal of pension revision applications for the State Govt. pensioners vide OM No 35175/F dated 29.11.2017 has issued procedures for submission of online/offline application for revision of pension through online "ARAPANA" portal in IFMS, Odisha. But the "ARAPANA" portal is meant for the pensioners/family pensioners who are drawing pension in Treasuries/ Public Sector Banks situated in the state of Odisha only. To apply for revision of pension online through "ARAPANA" portal of IFMS-Odisha as envisaged in above OM., there is no scope for the pensioners of Odisha who are drawing pension in other states under SSA.

Hence, keeping in view the above difficulties, the following procedures have been finalized by this office for the pensioners/family pensioners of Odisha who are drawing pension in other states under the SSA, for submission of their applications (offline) for revision.

1. Annexure-C as prescribed in above OM shall be dully filled up by the Pensioner/Family Pensioner and to be submitted to the Pension Disbursing Authorities i.e. Banks/ Treasuries as the case may be, along with a photo copy of the first page of the PPO Book (SSA).
2. If the pension/family pension is being drawn from the Public Sector Bank, then bank shall fill up the Annexure-D and submit both Annexure -C & D to the concerned Treasury from whom the SSA had been received, for onward transmission to O/o the A.G. (A&E) of the state.
3. If the pension/family pension is being drawn from the Treasury, then Treasury shall fill up the Annexure-D and submit both Annexure -C & D to the O/o the A.G. (A&E) of the state.
4. On receipt of the Annexure-C & D from Treasury offices, concerned State Accountant General Office shall forward both the Annexures- C & D and photo copy of SSA to the O/o the A.G. (A&E) Odisha for revision and authorization of revised pension/family pension through **Special Seal Authority**.

Hence, action may be taken at your end to circulate the above procedures among all Pension Disbursing Authorities under your jurisdiction for information and necessary action.
