In case of the former, pay for the purpose of D.A. will be as defined in F.R. 9(21) (a) (i) including stagnation increment. Those Govt. employees who exercised option to retain the scale of pay that existed prior to 01/04/2016 shall continue to draw the D.A. as is appropriate to the pay scales in force on 31/03/2016.


