In continuation to the Government Order No 93-F of 2023 dated 04.05.2023, it is hereby ordered that Government employees working in regular pay levels under 7th Pay Commission recommendations shall be paid Dearness Allowance as under:-

Existing Rate of DA per month	Revised Rate of DA per month	With effect from
42% of Basic Pay	46% of Basic Pay	01.07.2023

- i. The term 'Basic Pay' in the revised pay structure means the pay drawn in the prescribed level in the Pay matrix as per 7th Pay Commission recommendations, but does not include any other type of pay like special pay etc.
- ii. The arrears on account of additional installment of Dearness Allowance from July, 2023 to November, 2023 shall be credited in GPF accounts in respect of employees appointed prior to 01.01.2010 and paid in cash in respect of NPS employees. The revised Dearness Allowance shall form part of monthly salary from December, 2023.
- The payment of Dearness Allowance involving a fraction of 50 iii. paisa and above shall be rounded to the next higher rupee and the fraction of less than 50 paisa shall be ignored.
