I am to forward herewith the Government of Nagaland Finance Department. O.M. No.FIN/ROP/REL-8/87(Vol-II) dated 30-5-2018 to grant the Dearness Relief to the State Government pensioners/family pensioners for the purpose of fixation of pension under the Nagaland Services (Revision of Pension) Rules at the following rates.

- 1. 7th ROP Rules With effect from 01-1-2018 : -7%
- 2. 6th ROP Rules With effect from 01-1-2018 :- :-142%

Apart from these the Government of Nagaland, Departmental of finance ROP cell O.M.
